

## VocaList Contest Rules

1. The promoter is Shortlist Media whose registered office is at 26-34 Emerald Street, London, WC1N 3QA (the "Promoter"). The Administrator is Vision Critical Communications Inc., with a business address at 17 Hatfield, 2nd Floor, London, SE1 8DJ (the "Administrator").
2. The prize draw is open to entrants aged 18 or over resident in the United Kingdom, Channel Islands, Isle of Man, excluding employees and past employees (and their families) of Shortlist Media its printers and agents, the suppliers of the prizes, the Administrator and anyone materially connected to the administration of the prize draw.
3. There is no entry fee and no purchase necessary to enter prize draws offered by the Promoter from this website ([www.vocalistcommunity.co.uk](http://www.vocalistcommunity.co.uk)) ("Prize Draws").
4. Proof of identity and age may be required.
5. Use of false name or address will result in disqualification.
6. All entries must be made directly by the person entering the prize draw.
7. The prize draw period opens at 12:00 AM GMT on 1<sup>st</sup> September 2015 and ends at 11:59 PM GMT on 31<sup>st</sup> August 2016 (the "Contest Period"). To be eligible for the monthly prize draw there is no purchase necessary: you will just have to complete an online survey available at [www.vocalistcommunity.co.uk](http://www.vocalistcommunity.co.uk). All completed online survey's will be eligible and will be entered into one monthly draw during the Contest Period. Each entry to the prize draw becomes the exclusive property of Vision Critical Communications Inc. ('VCCI') and will not be acknowledged or returned. Prize draws will be conducted each month during the Contest Period. Each prize draw will be held on or within ten (10) business days of the last day of the previous month in the Contest Period (each a "Draw Date"). Entries received after the last day of the applicable month in the Contest Period will not be accepted.

9. Draws and winner notification: On each Draw Date, the winner(s) will be selected at random by an independent panel of judges from all correct and eligible entries received. The winner(s) will be notified in writing to the email address they provided to the VocaList website within fifteen (15) days of the applicable Draw Date. Winners must respond to notification of their prize within 5 days otherwise lose the right to accept the prize by email.
10. Re-draws: Administrator is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify the winner. If a selected entrant cannot be contacted or fails to respond within the allotted time the Administrator reserves the right to void that entry and select another eligible entrant for that prize (and in the event that the subsequent selected entrant cannot be contacted or fails to respond, a further entrant will be selected, until a winner is determined, provided further that in the event that a winner is not determined after attempts have been made to contact a total of three (3) entrants, Administrator may elect not to conduct any further redraws and not award such prize).

If a selected entrant(s) fails to complete, and return Winner Notification Survey to the Administrator within five (5) business days, the Administrator reserves the right to void that entry and select another eligible entrant for that prize.

12. No responsibility will be taken for entries lost, damaged, incomplete or illegible. Proof of posting will not be accepted as proof of delivery. Entries may be disqualified if incomplete or illegible.

13. The rules of the prize draw will be provided to each entrant entering the prize draw by completing an online survey at [www.vocalistcommunity.co.uk](http://www.vocalistcommunity.co.uk). The prize for each winner will be detailed in each new prize draw announcement made by the Promoter.

The Promoter or the Administrator each reserve the right to cancel any prize draw or amend these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the Promoter's or Administrator's control or at any other time.
